**SUBJECT:** Road Maintenance / Placer County FY 2019-20 RMRA Chip Seal Project / Western Placer County - Various Locations; Contract No. 001246, PJ00960

**ACTION REQUESTED**

Approve project specifications for the FY 2019-20 RMRA Chip Seal Project, Contract No. 001246, estimated to cost \$2,000,000 and authorize the Director of Public Works, or designee, to advertise for bids.

**BACKGROUND**

The Department of Public Works performs various surface treatments on County maintained roadways to protect, preserve, and extend their useful lives. Chip sealing provides a new wearing surface, some crack filling, and weather proofing. On rural roads chip sealing is the most cost-effective method to maintain and extend the life of these roads. Many older County roads were never constructed with a structural section; they were dirt farm roads that have only ever been chip sealed. The selection of roads for surface treatment is typically a function of the road condition, traffic volumes, and available funding. There are approximately 72 miles of roadway in this year's chip seal project.

Your Board's approval of the Department's FY 2019-20 Final Budget included funds for a chip seal project (PJ00960) for a total budgeted cost of \$1,000,000 with funding from the Road Maintenance and Rehabilitation Account (RMRA) gas tax funds (100%). RMRA revenues are trending higher, so we are proposing a \$2,000,000 project that includes the attached list of roads. Project bid books and specifications are on file with the Clerk of the Board. Roads to be treated may change depending on bid prices, which are subject to the volatility of the current oil market. The estimated completion date is summer of 2020.

**ENVIRONMENTAL IMPACT**

This project is Categorically Exempt from the provisions of CEQA as a Class I exemption, Section 15301(c) (Maintenance of Existing Facilities).

**FISCAL IMPACT**

The total cost of the project is \$2,000,000 and is available in the Department of Public Works FY 2019-20 Final Budget, Engineering Division, CC19006, PJ00960. This is a one-time project that is a part of the Department's road maintenance and resurfacing efforts.
