29 **COUNT ONE**

30 On or about February 2, 2024, in the County of Placer, the
31 crime of MURDER, in violation of Penal Code section 187(a), a
32

1 Felony, was committed by CORY ALBERT BLAKLEY & KIMBERLY RACHEL
2 BLAKLEY, who did unlawfully, and with malice aforethought murder
3 C.B., age 9, a human being.

4 It is further alleged that the above offense is a serious
5 felony within the meaning of Penal Code section 1192.7(c)(1).

6 It is further alleged that the above offense is a violent
7 felony within the meaning of Penal Code section 667.5(c)(1).

9 **COUNT TWO**

10
11 On or about February 2, 2024, in the County of Placer, the
12 crime of TORTURE, in violation of Penal Code section 206, a Felony,
13 was committed by CORY ALBERT BLAKLEY & KIMBERLY RACHEL BLAKLEY, who
14 did unlawfully and with the intent to cause cruel and extreme pain
15 and suffering for the purpose of revenge, extortion, persuasion and
16 for a sadistic purpose, inflict great bodily injury, as defined in
17 Penal Code section 12022.7, upon C.B., age 9.
18

19 **COUNT THREE**

20
21 On or about February 2, 2024, in the County of Placer, the
22 crime CRUELTY TO CHILD BY ABUSE, NEGLECT OR ENDANGERING HEALTH, in
23 violation of PENAL CODE SECTION 273a(a), a Felony, was committed by
24 CORY ALBERT BLAKLEY & KIMBERLY RACHEL BLAKLEY, a person, who, under
25 circumstances or conditions likely to cause great bodily harm or
26 death, willfully caused or permitted C.B., a child of 9 years, to
27 suffer or inflicted thereon unjustifiable physical pain or mental
28

1 suffering, or who, having care or custody of said, child, did
2 willfully cause or permit the person or health of said child to be
3 placed in such a situation where his or her person or health was
4 endangered.

5
6 **SPEC ALLEG- GBI - BRAIN INJURY, PARALYSIS**

7 It is further alleged pursuant to Penal Code section
8 12022.7(b), that in the commission of the above offense the said
9 defendant, KIMBERLY RACHEL BLAKLEY, personally inflicted great
10 bodily injury upon C.B, age 9, not an accomplice, and that said
11 injury caused C.B., age 9, to become comatose due to brain injury
12 and to suffer paralysis.

15 **SPEC ALLEG-WILLFUL HARM OR INJURY RESULTING IN DEATH**

16 It is further alleged pursuant to section 12022.95 that the
17 said defendant, CORY ALBERT BLAKLEY, under circumstances and
18 conditions likely to produce great bodily harm and death, willfully
19 caused and permitted a child, to C.B., age 9, to suffer, and
20 inflicted thereon unjustifiable physical pain and injury that
21 resulted in death, and having the care and custody of a child, under
22 circumstances likely to produce great bodily harm and death,
23 willfully caused and permitted that child to be injured and harmed
24 and that injury and harm resulted in death.

5 On or about February 2, 2024, in the County of Placer, the

20 On or about February 2, 2024, in the County of Placer, the
21 crime of CRUELTY TO CHILD BY ABUSE, NEGLECT OR ENDANGERING HEALTH,
22 in violation of Penal Code section 273a(b), a Misdemeanor, was
23 committed by CORY ALBERT BLAKLEY & KIMBERLY RACHEL BLAKLEY, a
24 person, who, under circumstances or conditions other than those
25 likely to cause great bodily harm or death, willfully caused or
26 permitted K.B., a child of 8 years, to suffer or inflicted thereon
27 unjustifiable physical pain or mental suffering, or who, having care

1 or custody of said, child, did willfully cause or permit the person
2 or health of said child to be placed in such a situation where his
3 or her person or health was endangered.

4 **COUNT EIGHT**

6 On or about February 2, 2024, in the County of Placer, the
7 crime of CRUELTY TO CHILD BY ABUSE, NEGLECT OR ENDANGERING HEALTH,
8 in violation of Penal Code section 273a(b), a Misdemeanor, was
9 committed by CORY ALBERT BLAKLEY & KIMBERLY RACHEL BLAKLEY, a
10 person, who, under circumstances or conditions other than those
11 likely to cause great bodily harm or death, willfully caused or
12 permitted M.B., a child of 7 years, to suffer or inflicted thereon
13 unjustifiable physical pain or mental suffering, or who, having care
14 or custody of said, child, did willfully cause or permit the person
15 or health of said child to be placed in such a situation where his
16 or her person or health was endangered.

22 On or about February 2, 2024, in the County of Placer, the
23 crime of CRUELTY TO CHILD BY ABUSE, NEGLECT OR ENDANGERING HEALTH,

25 committed by CORY ALBERT BLAKLEY & KIMBERLY RACHEL BLAKLEY, a
26 person, who, under circumstances or conditions other than those
27 likely to cause great bodily harm or death, willfully caused or
28


1 permitted C.B., a child of 6 years, to suffer or inflicted thereon
